Notes :

- Player from left should prepare scorecard.
- Players not ready to play or to be marker at the scheduled time will be disqualified.

The other two opponents will be automatically qualified, no game is required.

- The game format will be 2 sets for 7 ends. It MUST complete all 7 ends in the initial 2 sets.

If the game is tied after the two sets have been completed (each player having won one set or both sets having been drawn), a tiebreaker consisting of three ends should be played to decide the winner.
The winner of the tie breaker will be the player with the greater number of shots in the 3 ends.
If the shot scores are tied after the third end of the tie-breaker, the players should play a fourth tie-breaker end to decide the winner.

- Final ranking will be decided in the following order:

Point, shot difference, shot for, results of the game between the two players.

- Two bowls each direction during trial ends. Players not allow to visit head until after the delivery of her third bowl. Burn end is allowed and the end will be replayed.
- Winner of the game must notify result by e-mail to competition@hklba.org or by fax on 2577-5621, stating the competition, match reference number and the score.
- Copies of the scorecard need not be sent to HKLBA but must be kept by winner of the game in case of dispute.
